THE REPUBLIC OF SOUTH SUDAN (RSS):

Republican Order No.06/2013 for the **Granting of Pardons to the Forces which took up arms against the Republic of South Sudan, 2013 A.D.**

1. TITLE AND COMMENCEMENT:

This Order shall be cited as "The Republican Order No.06/2013 for the **Granting of Pardons to Forces which took up arms against the Republic of South Sudan 2013 A.D.**" and shall come into force on the date of its signature by the President of the Republic.

2. THE ORDER:

In exercise of the powers conferred upon me under Article 97(3) read together with Article 101(h) of the Transitional Constitution of the Republic of South Sudan, 2011, A.D, I, General Salva Kiir Mayardit, President of the Republic of South Sudan, do hereby issue this Republican Order for the

Granting of Pardons to the Forces which took up arms against the Republic of South Sudan as hereunder:-

- 1) **Maj. Gen. Gordon Kong** and his forces inclusive of Officers and men under his command for any crimes committed by them severally or jointly as a result of their mutiny and rebellion against the Republic of South Sudan.
- 2) **Maj. Gen. David Yau-Yau** and his forces inclusive of Officers and men under his command for any crimes committed by them severally or jointly as a result of their mutiny and rebellion against the Republic of South Sudan.
- 3) **Maj. Gen. Oyuok Ogot** and his forces inclusive of Officers and men under his command for any crimes committed by them severally or jointly as a result of their mutiny and rebellion against the Republic of South Sudan.
- 4) **Maj. Gen. Bapiny Monytil Wicjang** and his forces inclusive of Officers and men under his command for any crimes committed by them severally or jointly as a result of their mutiny and rebellion against the Republic of South Sudan.
- 5) **Maj. Gen. Johnson Uliny** and his forces inclusive of Officers and Men under his command for any crimes committed by them severally or jointly as a result of their mutiny and rebellion against the Republic of South Sudan.
- 6) **Maj. Gen. Munto Abdhalla Munto** and his forces inclusive of Officers

severally or jointly as a result of their mutiny and rebellion against the
