The Chairperson's Order No.01/2013 for the **Suspension and Formation of the Committee to Investigate the SPLM Secretary General, 2013 A.D.**

1. TITLE AND COMMENCEMENT:

This Order shall be cited as "The Chairperson's Order No.01/2013 for the **Suspension and Formation of the Committee to Investigate the SPLM Secretary General, 2013 A.D.**" and shall come into force on the date of its signature by the Chairperson of the Party.

2. THE ORDER:

In exercise of the powers conferred upon me under Article 25(1) (g) and (k) of the SPLM Constitution, 2008 A.D., read together with Article 23(2) of the Interim Basic Rules and Regulations, 2006, I, General Salva Kiir Mayardit, Chairperson of the SPLM, do hereby issue this Chairperson's Order for the **Suspension and Formation of the Committee to Investigate the SPLM Secretary General, Cde. Pagan Amum Okiech**, composed of the following members as hereunder:-



3. TERMS OF REFERENCE FOR THE COMMITTEE.

- (1) The terms of Reference for the Committee shall be as hereunder:
- (a) to investigate the SPLM Secretary General for allegedly mismanaging the affairs of SPLM, administratively and politically;
 - (b) to investigate the SPLM Secretary General for exhibiting insubordination to the SPLM leadership by using the public media to discredit the SPLM and its leadership;
 - (c) to investigate the SPLM Secretary General about his utterances of incitement of tribal sentiments in the Country by criticizing the Republican Order that lifted the immunity of Cde. Deng Alor Kuol and Cde. Kosti Manibe Ngai; without giving chance to the ongoing investigation;
 - (d) to investigate the SPLM Secretary General for his deliberate endeavor to create unnecessary divisions aimed at destroying the unity of the Party; and

- (e) to investigate the SPLM Secretary General for publicly undermining, showing disrespect to the leadership and impeding the proper functioning of the structures of the Party.
- (2) The Committee shall complete its work and submit its report to the Chairperson within thirty (30) days from the date of the signature of this Order.
